



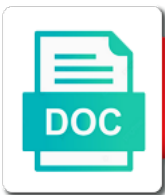

The bond is used to guarantee that the Principal will fulfill their obligations to the Fidelity. If the Principal fails to do so, the Fidelity will be responsible for paying the bond.
